European Studies: Made in Europe?

Today, Europe is studied all across the world. This global reality, however, finds itself only rarely reflected in assessments of the state and practice of European Studies as an academic discipline. The tie between Europe as the naturally accepted subject and object of research is still strong, as is the perception that the relevant scholarly centers of knowledge production about Europe are to be found largely if not exclusively in the global North. The workshop addresses the question of the study of Europe outside of „Europe“, i.e. outside of the global North, by challenging the premise that European Studies is made in Europe and by bringing into focus other regional centers and spaces of knowledge production about Europe, thereby working towards a more global perspective.
